Selection of the Target Group

The members of the Selection Committee have met to conduct the selection of the Target Group on the basis of the revised Methodology for the selection of the Target Group.

The committee president Constantin-Adi Gavrilă and members Daniela Birtu, Valentin Vitkov are personally present, as with the other members of the committee Cristian Valeriu Stanciu and Petar Gruev the connection is made online via Zoom online meeting: permanent link 777-912.6294.

According to the methodology for selection of the target group, the Committee should check the applications submitted according to the methodology, such as the availability of documents and completeness of the applicant's dossier as a member of the project target group. Then, the committee will select the applications for members of the target group in observance of the total points received and of the













principles of equal chances between men and women, equal opportunities and nondiscrimination.

According to the methodology, each application will be evaluated on the basis of the eligibility and selection criteria. Applications will be ranked on the basis of the total points received. When applications exceed the number of the targeted target group / for Bulgaria 150 persons / the first-time, first-to-right principle will be applied.

The results of the selection of the target group will be reflected in an evaluation and selection report, attached to these minutes, which will be published both on the project website www.jurisCBP.ro and will be available at both crossborder legal centres (Dolj and Vidin).

In view of the methodology and its implementation, the Committee finds that the applications for participation in the Target group in the Dolj district are 193 and in Vidin there are 157 applications for participation in the project target group.

The Committee has checked the completeness and the correctness of the information contained in the dossiers, and identified the applications that were submitted according to the methodology and contained the necessary documents. In this sense, the Committee carried out an analysis of the submitted applications.

The Committee then proceeded to evaluate the applications according to the benchmark criteria and the scoring set out in the methodology, namely:

- 1. Student from a higher education institution 1 point
- 2. Graduate higher education institution 2 points
- 3. Student from higher legal education 3 points
- 4. Graduate of a law school 4 points

B. Status of the labor market

1. working (employed) - 1 point

 - 1. Small 1 point
 - 2. High 2 points
 - 3. Very high 3 points
- C. Level of mobility in the cross-border area in the last 5 years
 - 1. Small 1 point
 - 2. High 2 points
- D. Opportunity to participate in Activity A 10 (as specified below)
 - 1. Small 1 point
 - 2. High 2 points

Due to the volume of applications, the Committee decided to record the results of the scoring in a tabular form and is an annex, an integral part of this document - Annex 2 a (for Dolj) and b (for Vidin). The results are as follows: for the Dolj region, 155 persons were selected for the target group and 157 persons were selected for the target group of Vidin. The additional 5 and 7 persons to the default 150 were selected in order to address the risk of drop-off from the Target Group.

The Evaluation and Selection Committee shall then disclose the results of the project selection process to the project target group.

The attached Target Group selection report will be published today on 21.10.2017 on the project site and is at the disposal of the stakeholders at the headquarters of the two cross-border legal centers (Dolj and Vidin).
